April Program

The back cover of the April Issue of *Fine Woodworking* Magazine features a gorgeous Federal style serpentine front secretary book case built by our own Bob Stevenson. This amazing piece took about 1400 hours for Bob to complete. Bob will discuss the many aspects of the construction from hand joinery, veneering, inlay, and working curved surfaces to making glazed doors and finishing. He also will discuss where one draws the line between machining wood and hand working wood in making a reproduction piece on a commission.

Many of us know about Bob's tireless work in the San Diego Fair's Design in Wood Exhibition. His effort, along with many of the club member volunteers, has created one of the largest and finest displays of woodworking in the United States. Many people attend the fair just to see the incredible pieces displayed in this exhibition. This month's program will be an inside look at a traditional method of woodworking and overview of the creation of an incredible piece of art. We hope you will join us for a very educational and information packed evening.

Bob has been a long time woodworker. His woodworking experience started in high school shop where he felt most at home. After serving twenty of a thirty year career in the Navy, Bob inherited his great-great uncle and great-grandfather's tools – an entire jointer's chest of tools from the mid 1800's.

As Bob approached retirement he started taking classes at Palomar College in Furniture Technology. Upon retirement he started a furniture restoration business. A few years later he graduated from Palomar College. In addition to his restoration business he also taught finishing courses at Palomar for several semesters before doing the furniture business full time.

Over time he started making more pieces and had less time for repair. Although he has made many different pieces of various styles, Bob likes Federal Period furniture the best. After having some of his work published, he has been lucky to find clients who also like the same style of furniture. Although he still does some restoration work, he spends most of his time doing commissions of reproduction furniture.

Bob has been a member of the Society of American Period Furniture Makers since it started in 1999 and has been a member of the Advisory Committee for four years. In 1986 he joined SDFWA and in 1987 he started helping at the Fair. In 1995 he took over as Superintendent of Design in Wood when Pat Edwards stepped down. Showing his work at the Design in Wood was extremely rewarding. Having one's work recognized is a great feeling. Knowing that feeling is what drives Bob to continue his efforts to improve the Design in Wood Exhibition and make it attractive for other woodworkers to show their work, a job he couldn't do without the ever continuing support of the San Diego Fine Woodworkers Association.

Be sure to join us for what promises to be an impressive program. See you there!

SATURDAY, APRIL 29th SHOP TOUR at 9AM

WORK SHOP OF STEVE ALWARDT

Our last shop tour with Al De Vries demonstrated the potential of an 11 X 20 foot workshop where we saw some great storage ideas for a small work space.

On April 29th at 9am you will be able to see what you can do with 1944 sf of workspace at Steve Alwardt's shop.

Steve has attended many of the Palomar College classes and has been working with wood for 30 years but his most recent interests are in marquetry. A few months back you may have seen his latest project on the brag table, a beautiful eagle panel that was completed in record time with no less attention to detail. If you didn't see it, now's your chance.

The speaker at the general meeting held on March 29th talked about various sharpening systems including the Lap Sharp System. Steve will give an actual demonstration of that system and answer any questions you may have, this from an actual user of the system and not the "salesman" or "company rep". We will also see his flip top veneer press and his collection of various tool boxes.

There is plenty of parking, but due to the width of the driveway, the first one in will be the last one out. He advises to NOT park in the street because it is narrow with no shoulder. If you use Mapquest for directions, please use the following advice from Steve: Mapquest will instruct you to turn down Holly Lane which is a bumpy dirt road. Instead travel east an additional 1/4 mile on Highway 76 and turn left at the next traffic light, which will be North River Road.

From Interstate 5
Exit Highway 76 and head east for approx. 6 miles. Turn Left onto College Boulevard. At the end of College Boulevard, take a right turn onto North River Road. At the next traffic light, take another right at North River Road (**not a duplicate instruction!**). Travel for approx. 2 miles then take a left onto Sleeping Indian Rd. Travel approx. 1.5 miles and turn left at 1055 Sleeping Indian Rd.

From Interstate 15
Exit Gopher Canyon Road and head West. At the end of Gopher Canyon Road, take a right on East Vista Way. Travel approx. 1 mile, then turn right onto Highway 76 towards Bonsall. At the next traffic light, take a left on North River Road. Turn right onto Sleeping Indian Rd. The shop is at 1055 Sleeping Indian Rd. on the left hand side.

It is almost time again for the Design In Wood show as part of the San Diego Fair. This year is our 25th Anniversary and we are planning an exhibit that will give the history of the association over the years. We have 21 different categories and many more prizes than when we started 25 years ago. I encourage you to enter.

Design In Wood entry forms are at our sponsors and also available on-line at http://www.sdfair.com/fair/pdf/06entry_wood.pdf. Entry forms must be received by 5 PM, April 28. We have 6 awards reserved for SDFWA members. First, second and third place awards for Novice and Professional categories. The Novice class is reserved for members who have not previously won a ribbon and the Professional class is for members who have previously won. These are additional awards reserved for SDFWA members and are in addition to the awards available to all entries.

We still need volunteers for working the floor and the chair shop. Sign-up sheets will be available at the meeting and on line at <http://www.SDFWA.org>. There are plenty of positions available and we need your help. Building children's chairs in the 19th Century cabinet shop is a great way to polish up your hand tool skills or learn new techniques. Conversing with the crowds is always fun. We also need volunteers for the floor to watch over the exhibits. Floor duty is also rewarding. People always have questions about the entire. We supply you with information on all the pieces and you don't have to be an expert. It also gives you a chance to spend some time really looking over the different works on display.

There are usually over 300 entries and I know from experience that I seem to find something new each time I go through the show. Finally, we always need your help for setup and tear down. No sign up necessary for this. Just show up. No skill needed. If you have a screw gun, bring it. We will even feed you coffee and donuts in the morning and also provide lunch. It is always a lot of fun and a good way to meet a lot of your fellow woodworkers. Times and dates are provided in Bob Stevenson's article on the Design in Wood Show.

Speaking of volunteers, this organization runs totally on volunteer help. Besides the 5 elected board members we have 27 different committees. This requires a lot of help from a lot of dedicated people to make this organization function. We are always looking for volunteers. If you think you have a few hours a month to contribute, please contact me. The payback is much greater than the time spent.

Our meeting this month features Bob Stevenson. Bob builds American period reproductions using the same techniques as the master furniture makers of the 17th and 18th century. Bob Flexner has operated his own furniture making and restoration shop in Norman, OK for 30 years. For the last 15 years, he has taught wood finishing and restoration. His accomplishments include writing the authoritative and best-selling book, "Understanding Wood Finishing," now in its second, fully revised edition, editing *Finishing and Restoration (Professional Refinishing)* magazine, making the award-winning videos, "Repairing Furniture" and "Refinishing Furniture" for Taunton Press, and writing the long-running columns "Finishing" in *Woodshop News* and "Flexner on Finishing" in *Popular Woodworking*. Bob is probably best known for defining the products used in wood finishing and organizing them into categories that make them easily understandable.

DESCRIPTION OF SEMINAR
